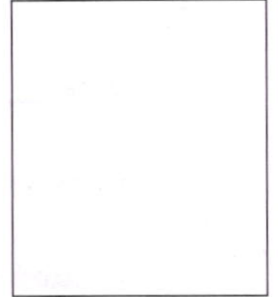

3. If my ward requires a late permission in the hostel after 10:00 pm advance consent from the parents & hostel authority is necessary.

5. My ward will be responsible for any loss or theft of her / his mobile, valuable & cash.
6. My ward will take proper care of the hostel facilities of furniture & fitting. If any breakages are found that we agree the cost will be borne by us.
7. My ward will not indulge in any indispline matters and create any problem in the hostel or to fellow students, if found his admission will be cancelled.
8. My ward will remain in her room after 10:00 pm or will not loiter around or outside the room failing which, disciplinary action including fine of Rs. 100/- is acceptable.

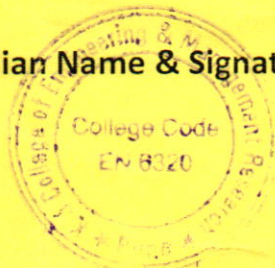

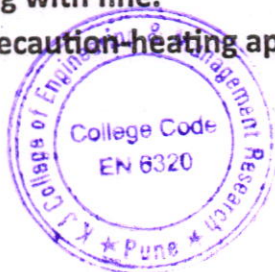

Rules and Regulations for KJEI Hostel Inmates

All Inmates of K.J's Group of Institutions shall strictly follow the following rules.

1. Admission to hostel will be given to bonafide regular students of KJ's Institutes only. Stay in hostel is not a right of the student but a facility provided by the institute.
2. Admission to hostel will be confirmed only student pays hostel fees and deposit.
3. Stay in hostel is solely for the purpose to facilitate academic activities at KJ's Institutes.
4. All hostel Inmates shall submit three passport size photographs & get hostel identity card. Hostel ID card will be required for entry to the hostel for identification. Students should carry along with the hostel and institute ID card at all times.
5. The management has rights to change / after accommodation rules & regulation.
6. Students will have to apply afresh before 31 May if desirous of staying in hostel in the next academic year.
7. Allotment of accommodation is as per the management norms.
8. Hostel Inmates should keep hostel room / premises, neat & clean. Posters are not permitted to be displayed. No marking on walls, doors and no extra attachments of electrical fitting to be allowed.
9. Students should take care of their valuables & cash. Authorities are not responsible for any theft or loss.
10. Lock & Key for the room is to be brought by the student & one key to be kept in the office of resident rector for an emergency.
11. At the time of admission each student should check furniture provided in the room and report if not in order at the time of allotment & should be returned back to the hostel authorities in proper shape & condition at the time of vacating the room.
12. The reporting time in hostel 10.00 PM.
13. Parties or birthdays celebrations inside the hostel rooms are strictly prohibited.
14. Creating indiscipline / mischief / fight / misbehavior / may lead to expulsion further hostel. Further, such students may not be considered for the hostel accommodation in future. No refunds will be made to expelled.
15. Smoking, consumption of alcohol, use of drugs & chewing of tobacco inside the hostel is strictly prohibited. Such students will be expelled from the hostel & can rusticate firm the college.
16. Playing of radios / audios cassettes inside the room is permitted without disturbing others. If disturbance is reported the resident rector / rector can confiscate the musical instrument, which will be returned at the end of the semester.
17. Students will report to rector / warden any untoward happening in the hostel Inmates. Students suffering from injury, sickness will reports to Rector / warden for help Cost of the damages made to the hostel property (including furniture) shall be recovered from the inmates along with fine.
18. Safety precaution heating appliances such as electric stove, heaters, gas stove, hot

plates, iron etc. are not permitted to be use in the room & if they found using the appliances will be confiscated along with fine. No change of room is permitted without written permission of Rector.

19. Students of this hostel are to vacate the hostel after 3 days of the final exam. No further stay is permitted.

20. Student should not touch any electrical wiring in the room and outside panel fittings, which may cause fatal accidents & the management will not held responsible.

21. It is a responsibility of all students to switch off electrical fans, lights when not in use.

23. Students taking tea, cold drinks and other eatables from the general stores should use dustbins provided and do not carry empty tins and cups to unwanted places.

24. The failed students are not allowed to stay in the hostel. They should vacate the hostel within 3 days after declaration of results.

25. During examination period failed students are allowed to avail the hostel facility by paying nominal charges.
